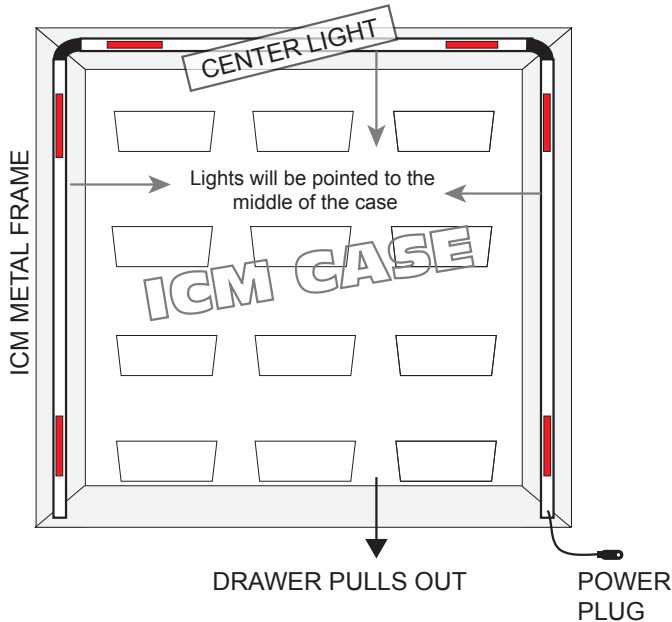

INSTALLATIONS

1. Remove the ticket dispenser drawer.
2. With the wipes provided clean the under side of the ICM aluminum frame where the tapes will be applied. Allow two minutes to dry.
3. Remove all the red tape liners. Be careful not to let it stick to any objects. Avoid touching the tape surface.
4. Start with the center light. Install it in the front side (customer side) of the case. Place the light and apply firm pressure to the tapes area for 10 seconds.
5. Do the same for left and right side lights. Make sure the tape is making good contact with the framing.
6. Route the Power Plug through a side opening of the case so it will not interfere with the drawer.
7. Connect the light power plug to the power supply.
7. Plug the power supply to an AC outlet.
9. If you have purchased DC extension cord or power splitter accessories please use as instructed and needed.

The system is intended to stay on at all times as long as it is plugged in. Should there be a need for turning off the lights, it is best to unplug the lights from the power supply jack.
